Experiences on the Work with Mulitilevel Sources as a PhD fellow

This lecture will be a discussion of the challenges encountered when working with multiple sources. It will also investigate the challenges of the writing process and a balanced PhD life.

This lecture is focusing on the use of legal sources in research – and the challenges of different levels of regulation as well as the application of non-legal sources.

In this lecture Lærke will share her experiences on these matters and she will invite for an open discussion on challenges and ways of coping with them. In her PhD thesis Lærke researches into a multi-level governance system on a national, EU and international level. The thesis deals with environmental protective regulation of agriculture in a social study of the law and applies relevant systems theory on social and ecological systems.

The research also includes non-legal sources such as political agreements and ministerial covers as well as bio scientific research.
