## PhD Course and Conference

Dear PhD Scholars,

You are cordially invited to participate at this year's PhD seminar on research in tax law taking place in Bergen, Norway.

The PhD seminar will take place at Solstrand Hotel & Spa Tuesday November 23<sup>rd</sup> and Wednesday 24<sup>th</sup> 2021. On the following day, Thursday November 25<sup>th</sup>, you are also welcome to participate at a tax conference to be held at The Law Faculty at the University of Bergen.

Solstrand Hotel & Spa is located about 30 km outside Bergen. With its magnificent view of the fjord and the mountains, Solstrand has fascinated guests from Norway and around the world since 1896. We look forward to greeting you there.

We have arranged a variety of hotel packages for you to choose from. There are four alternatives; package one and two are, in particular, tailored to the needs of visitors travelling to Bergen/Norway. The seminar starts at 10 AM on Tuesday 23<sup>rd</sup> and therefore these alternatives have taken account for an extra overnight stay on Monday November 22<sup>nd</sup>.

Transportation to and from Solstrand has been arranged. On the morning of Tuesday November 23<sup>rd</sup>, a bus will collect those who are in Bergen City and another bus those who are staying at Scandic Flesland Airport. In the afternoon Wednesday November 24<sup>th</sup> a bus will collect guests from Solstrand who are due to return to Flesland Airport. There will also be a buss collecting guests on Thursday November 25<sup>th</sup> transporting participants to The Law Faculty.
