

## PhD Seminar and Conference in tax law – Bergen 3-5<sup>th</sup> October 2023

Dear PhD Scholars,

You are cordially invited to participate at this year's PhD seminar in Bergen.

The PhD seminar will take place at Solstrand Hotel & Spa Tuesday October 3<sup>rd</sup> and Wednesday 4<sup>th</sup> 2023. On the following day, Thursday 5<sup>th</sup>, you are also welcome to participate at a tax conference to be held at The Law Faculty at the University of Bergen.

Solstrand Hotel & Spa is located about 30 km outside Bergen. With its magnificent view of the fjord and the mountains, Solstrand has fascinated guests from Norway and around the world since 1896. We look forward to greeting you there.

We have arranged a variety of hotel packages for you to choose from. There are four alternatives; packages 1 and 2 are, in particular, tailored to the needs of visitors travelling to Bergen/Norway. The seminar starts at 10 AM on Tuesday 3<sup>rd</sup> and therefore these alternatives have taken account for an extra overnight stay on Monday October 2<sup>nd</sup>.

Transportation to and from Solstrand has been arranged. On the morning of Tuesday October 3<sup>rd</sup>, a bus will collect those who are in Bergen City and another bus those who are staying at Scandic Flesland Airport. In the afternoon Wednesday October 4<sup>th</sup>, a bus will collect guests from Solstrand who are due to return to Flesland Airport. There will also be a buss collecting guests on Thursday October 5<sup>th</sup> transporting participants to The Law Faculty.

PhD scholars who register for the course are eligible for an accommodation and local transport grant, provided by The University of Bergen. This grant will pay for the hotel package that the scholar chooses.
